Assists with weekly and monthly vaccine inventory and performs other duties as needed.

MINIMUM QUALIFICATIONS: Bachelor's degree in Nursing from an accredited college or university **AND** current Georgia license to practice as a Registered Professional Nurse **AND** CPR certification **OR** Associate's degree in nursing from an accredited college or university **AND** One year of PHN experience **AND** completion of a PHN course within one year of hire **AND** current Georgia Registered Professional Nurse license **AND** CPR certification.

PREFERRED QUALIFICATIONS: In addition, preference will be given to applicants with previous experience as a Public Health Nurse serving adult health (i.e. STD, FP, BCCP) and immunizations; ability to adapt to new environment; teamwork oriented.
