**MINIMUM QUALIFICATIONS:** Bachelor's degree from an accredited college or university **AND** six months of related experience **OR** Associate's degree from an accredited college or university **AND** Two years of experience in a related area **OR** Four years of experience in a medical related field **OR** licensure as a registered nurse **AND** One year of nursing experience **OR** One year of experience at the lower level Communicable Disease Spec 1 (HCP080) or position equivalent.

**PREFERRED QUALIFICATIONS:** In addition to the minimum qualifications, applicant must possess a strong knowledge of HIV/AIDS and STD's. Experience in conducting outreach and disease intervention. Completions of ISTD and or ASTDI and PassPort. Case Management skills and Phlebotomy are a plus. Also, Bilingual in Spanish is preferred.
