### **Overview**







- As of July 14, DeKalb County has reported 147,229 confirmed cases of 2019 novel coronavirus disease (COVID-19) and 1,597 confirmed COVID-19 deaths, an increase of 1,686 cases (+1.2%) and 5 deaths (+0.3%) since the last report on July 8. Confirmed cases only count cases with a positive PCR test, and do not include antigen tests, at-home tests, or antibody tests.
- During the week of 7/7 to 7/13, DeKalb County had "high" community levels, with 267 new COVID-19 cases per 100,000 people in the last 7 days, 12 new COVID-19 hospital admissions per 100,000 people in Dekalb, and a 5.8% inpatient bed utilization rate for COVID-19 patients
- 2,611 COVID-19 cases (308 cases per 100,000 population) were diagnosed in the most recent 14-days (6/25 7/8), a **5.9% INCREASE** from the previous 14-days (6/11 6/24)
- Of all persons diagnosed with COVID-19 in DeKalb, 5.9% needed hospitalization and 1.1% died
- As of July 13, Georgia Department of Public Health reported that DeKalb accounted for 7.3% of the total number of COVID-19 cases in Georgia to date
- As of July 13, Georgia Department of Public Health reported that DeKalb has administered 1,243,595 vaccines, and has 513,122 residents with at least one dose (68%) and 460,704 fully vaccinated residents (61%)










### **Age Distribution of COVID Cases**








#### **COVID-19 Testing and Positivity**







## **COVID-19 Related Death Demographics**











# **Cases by Vaccination Status**





# **Case Outcomes by Vaccination Status**




